 5. Since the last meeting – Exec members consulted by e-mail regarding a travel funding request note from Antoine Rousseau. The consensus was to remind him of his contract but to offer a small good-will additional payment.

Normal Monthly Agenda

1. **Minutes from the June 25, 2014 meeting** – Approved as distributed.
2. **Treasurer’s Report** (Bob) - With just a quick look, ESS had a loss of \$7,999.31 and SS had a profit of \$1070.46. ESS had 43 empty beds. Have we talked with Judy Erickson? Will Boston Centre be paying half of this? This is not a sustainable picture from PCI perspective either. Should it be made a family session? (It’s not clear what impact there would be on the program.) There may be other ideas out there, such as a focus on performance and high-impact. Judy Savage might be willing to give us a price break for a year or two if we want to re-brand it. The PCI plan is in flux, so there are options about shifting the schedule. ESS hasn’t managed to attract a significant following. They got 92 people only by pestering their friends, and there was very little publicity this year.

3. **Reports from Liaisons** –
 - a) Fall Concert (John) – November 8, 2014 – No Report.
 - b) Highland Ball (Bob) – April 18, 2015 – Sara would like to attend the August meeting. It would be better if she could send her ideas in advance and then limit her time to 15 minutes.
 - c) Pinewoods Benefit Ball (Betty) – December 6, 2014 – Betty has not heard from Hannah. The Hall is now being run by the city of Salem, but we have been assured that we are still on schedule, and the city has the deposit.
 - d) ESS Pinewoods (Jean) – See above information in the Treasurer’s Report. RSCDS needs to appoint two people on to the committee. Meghan Murray would like to stay on, but Jerome Fong has concluded his stint.

- e) Pinewoods Scottish Sessions (BDan) – There were two notable injuries this year; one requiring surgery. Due to last minute cancellations, there were 144 campers for Session I and 143 for Session II. Judy Savage charged for a full camp, so we may get a small amount refunded to us. There was e-mail discussion concerning Antoine Rousseau’s travel stipend (mentioned above). Both Antoine and Linda Henderson have sent gracious thank-you notes. The chairs are just tidying up some loose ends.
- f) New Hampshire Highlands (Vickery) – August 22 – 24, 2014 – The teaching and music staff is in place, and everyone is gearing up for a great weekend. There is still room for a few more dancers, so spread the word.
- g) Branch Activities at NH Highland Games (John) – No report.
- h) Teaching and Music Committee (Betty) – The Committee did not meet in July.
- i) Tartan Times (Beth) – The main issue is the changeover to someone else being liaison. The most recent edition was nearly a digital copy.
- j) Demonstration Team (Alex) - No report.
- k) Membership (Bob) – The Great Barrington class has 9 people, and where they are now dancing requires insurance. Bob is waiting for an answer from the insurance broker and hopes to have an answer by tomorrow. They count a dance class as “an event.” Bob has spoken with Ted and will send the information concerning the additional fees to him. It was moved to re-accept them as a Branch Class, with the provision that they will need to pay the extra cost of adding them to the insurance until the insurance year changes over.
Exec needs to add to the Policies and Procedures concerning what designates a Branch Class and to include dates.
- l) Web Site and Publicity (Kat) – The webmasters will archive the PW Gazette and also the list of dances taught in classes.
- m) Bookstore (Vickery) – The Bookstore did very well at Pinewoods and cleared out some older stock. Dawn and Mike will be ordering more of the New Manuals and Prescribed Dances for the Candidates. In addition, they will be ordering Book 48 and its CD, the Third Graded Book and its CD, the Imperial Book, and some copies of Sellings’ Handbook for Teachers. They are working to get the Pinewoods Collection republished and hope to have it available soon. A number of suggestions for books and CDs to purchase were received from the people attending Pinewoods. Bob noted that he needs the consignment sales income and data.
- n) SAGM - Scheduled for November 3, 2014.

- b) People should put thought into ESS issues for discussion in the next month. We need a task force. The Pinewoods schedule is in flux, and CDSS might be shrinking sessions or weeks.
- c) Exec also needs to be thinking of someone for TMC for the AT-Large position. The At-Large person typically brings dancer perspective, not Teacher or Musician. Send suggestions to Jeremy before the next meeting.
