1. Minutes from the previous meeting *Approved*.

2. Treasurer's report (Cathy)

- i. First 26 days of new fiscal year: Membership and donations only income so far. Expenses for fall concert, deposits for next spring, subsidies for Brunswick and Northampton. Increase in net assets: \$4,346.42 so far. Cash in bank: \$71,007.00.
- ii. Approve music subsidy for Albany, ready when they ask.
- iii. Last fiscal year: Ended the year with an increase of net assets of \$1,943. Cathy will share these numbers at the SAGM.

3. New business

- a. Complete prep for Semi-Annual General Meeting (AGM) November
 - i. **Alena** to email the people directly to ask for reports. If reporters are present, they are to give the report. If they are present via Zoom, Alena will read their report out loud.
 - ii. Alex requested assistance with setting up/putting away chairs.
 - iii. John asks that the Zoom link be sent out a couple of days before the meeting but ensure everyone knows to look for it. Linda will send reminder email to go out 10 days before the event.
- b. Delegates and ballot for HQ AGM—confirm discussion of higher fee; review who's voting and candidates for HQ officed
 - i. VOTING DEADLINE IS SATURDAY 29 OCTOBER (Jeremy, Linda, Alena, Cathy are designated voters)
 - ii. **Motion 8.1** Membership subscription "The Management Board proposes that for the year from 1st July 2023, the basic full annual subscription

- shall be increased to £26 per annum, with other membership subscriptions based pro-rata on this amount". VOTE: *FOR*
- iii. **Motion 8.2** Amendments to the wording of RSCDS Rules & Procedures "The Management Board proposes an update to the sections covering Management Committee Remits and the clarification of 16.1a" VOTE: *FOR*
- iv. **Motion 8.3** Updates to the Articles of Association and Rules & Procedures regarding Junior membership "The RSCDS Herts & Borders Branch proposes the introduction from 1 July 2023 of non-subscribing junior membership for children under the age of 12. It would be free for children under the age of 12 to become a non-subscribing junior member" VOTE: **FOR**
- v. 6 bios of people elected positions. VOTE: Andrew Timmins from Germany and Erica De Gannes from Canada. otherwise, we agree to vote for whoever has the most geographic diversity.

 - i. 157 members as of today, compared to 149 last year this time. Second reminder email going to members shortly. Peter to approve and send asap. Cathy will nudge Peter O.

 - i. NEFFA Howard, Charles, Karen have each applied to do a NEFFA workshop. No indoor performances.
 - ii. Highland Ball program is nearly complete, Elizabeth to make flyer, Tom gave his input on tunes. MCs are being narrowed down.
 - iii. Pinewoods Tom is working on musicians. Robert is working with teachers and MCs. Switch from 12 to maybe 11 classes for full time teachers, clarifying the titles of the classes.
